## \* PSU FOUNDATION HOW TO MAKE A BEQUEST

Thank you for including PSU in your estate plans! As with any decision regarding your estate, we encourage you to seek the advice of professional counsel when considering a gift to the Portland State University Foundation.

**If you already have a will or trust**, review the documents to determine if any changes in your family or other circumstances warrant revising the document. If you wish to add Portland State University Foundation for a gift in your existing will or trust, contact the attorney who drafted the document and request a simple amendment.

**If you don't have a will or trust**, contact a competent attorney to have these documents prepared. If you don't know who to contact, seek a recommendation for an estate planning attorney from family members, friends, or colleagues at work. You may also contact your local bar association lawyer reference service for a referral. See sample bequest language below.
